With reference to your above letters, it is to inform you that certificate of ownership submitted by Mr. Feroz Khan is genuine. Barve Road, Kurla (E) Mumbai - 400 023 has applied for using his snake as a performing animal for training / exhibition in the Film / Serials / Ad films etc. and submitted the ownership certificate issued by this office in the name of Shri Dinmohammed Bhaisaheb Shaikh. But Feroz Khan did not have any rights to use this ownership certificate, only Shri Dinmohammed Bhaisaheb Shaikh has the right to use this ownership certificate. The certificate issued is not transferable as per existing law.
